ORDER SEALING GUARDIAN AD LITEM REPORT TO COURT

3. The information contained in the Guardian Ad Litem Report to the Court dated March 21, 2024, should be sealed to avoid substantial injury to third parties, to wit, the minor child who is the subject of this action.

4. The progress docket and other records generated to document activity in the case are not determined to be confidential.

5. All information contained in the Guardian Ad Litem Report to the Court dated March 21, 2024, is deemed confidential.

6. The only persons permitted to view the confidential information are the parties, their counsel of record, and the Guardian Ad Litem in this case.

7. The degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth herein, and no less restrictive means are available to protect those interests.

Based on the foregoing findings of fact, it is hereby ADJUDGED as follows:

1. The Clerk of Court is directed to seal the Guardian Ad Litem Report to the Court dated March 21, 2024, in this matter.

2. The Clerk of Court is directed to publish this Order in accordance with Fla. R. Jud. Admin. 2.420(e)(4).
